#### **GSHCC Response Actions- COVID-19 Update**

The Granite State Health Care Coalition has been involved in a myriad of response activities related to COVID-19 in support of our healthcare partners, members, state and federal partners including:

- Arranging temporary respite, isolation, and quarantine housing for healthcare workers
- Assisting hospitals with required federal and state reporting through Juvare
- Training partners on Juvare implementation
- Supplying federal partners with nightly data reports
- Supplying members with vendor resource lists
- Identifying gaps in reporting and working with healthcare partners on reporting mechanisms to supply active solutions

#### GSHCC COVID-19 Projects Mid-Term After-Action Review (AAR) Project

The Granite State Health Care Coalition has contracted with the Olson Group, LTD. to conduct a comprehensive mid-event After Action Review (AAR) process relative to COVID-19. The contractor will develop a written strategy to engage GSHCC partners from healthcare and public health sectors in this AAR initiative to help capture a more comprehensive view of NH's COVID healthcare response. All initiatives will be completed with the appropriate stakeholder input and approval. The AAR will include an Executive Summary and After-Action Report Toolkit to assist partners in spring boarding internal AAR processes, conduct internal gap analyses, implement plan improvements, and identify opportunities for grant funding.

#### **Immunization Planning Project**

The Granite State Health Care Coalition has contracted with Hagerty Consulting, Inc. to implement a strategy to increase mass vaccination capabilities statewide. This initiative aims to increase the number of closed Points of Dispensing (POD) agreements with additional healthcare agencies, including those that serve priority and vulnerable populations. Hagerty will also facilitate the development of an action plan and timeline to help reclaim and reengage existing closed PODs within the state. Part of this work includes the development of closed POD templates for inpatient and outpatient operations with supplemental documentation to facilitate rapid planning. In collaboration with others, the contractor will also assist the GSHCC in developing and coordinating on-demand just-in-time training for closed POD operations for use by healthcare partners and the regional public health networks. This project will occur in collaboration with the State of NH Department of Health and Human Services (DHHS) and the thirteen public health networks.



"Monadnock Community Hospital's response to the COVID-19 pandemic began February 26, 2020, following a webinar sponsored by the American Hospital Association (AHA). That day, the AHA advised all healthcare administrators to open their Incident Command teams and begin preparations for the emerging outbreak. Since that day, the Coalition has been my primary, go-to resource for accurate and timely information. I rely on their daily email briefings for an essential snapshot of the pandemic, delivered in time for the morning coffee. The Coalition has also produced a resource list of PPE and other hard-to-find items outside of our usual supply chains, which they update all the time. They also track and maintain Juvare, the hospital's reporting system for the State of NH. We use this system for all emergency events, along with our daily bed reporting, and most recently, the Federal reporting for COVID-19. To summarize everything they do for us in a few sentences is difficult but, from my perspective, they provide a critical level of comfort, knowing I have a trusted resource I can turn to. No matter how big or small the request may be, I know they will help me find the answers and resources Monadnock needs to be successful in these challenging times."

- Practice efficient time management



#### **Ongoing GSHCC Activities**

#### Hazard Vulnerability Analysis (HVA)

The GHSCC is working on revamping the HVA process for this grant year so that we may determine our greatest vulnerabilities to bolster planning, revise training plans, and enhance exercise efficacy. We will keep you informed as this process advances. Your participation is key! The HVA is scheduled for completion by June 2021.

#### **Pediatric Surge Annex**

The Pediatric Surge Annex applies to a coalition-level response to a mass casualty event involving a large number of pediatric patients. This pediatric-focused operational annex serves as an annex to the GSHCC Coordination Plan. It is intended to be a high-level response plan, identifying key resources that exist within the coalition. This Annex is scheduled for completion by December 2020.

#### **Infectious Disease Surge Annex**

The Infectious Disease Surge Annex is a new ASPR requirement that must reflect GSHCC actions relative to a coordinated healthcare response to a range of known and emerging infectious diseases. The GSHCC must have the ability to pivot to respond to a myriad of infectious disease agents and severity scenarios. The timing of this deliverable is fitting and will be tailored to reflect the *State of New Hampshire High Threat Infectious Disease (HTID) Plan* and accompanying *Appendix 2: Pandemic Influenza Response Plan* assumptions and response structure framework. This Annex is scheduled for completion by June 2021.



#### Juvare Healthcare Information Management System Highlight

Fall 2020 marks the one-year anniversary of the statewide implementation of the Juvare healthcare information management system (HIMS). Juvare's dynamic inventory of healthcare and public health platforms allows for situational awareness, data collection, incident management, inventory management, patient tracking, and volunteer management. Shortly after preliminary training sessions with healthcare and public health partners, New Hampshire became immersed in the COVID-19 pandemic response. This emerging threat provided the healthcare sector with the opportunity to test and implement the new tools to assist with a coordinated and sustained statewide response. Four platforms quickly became essential to an efficient and coordinated statewide COVID-19 response.

Hospitals, long-term care facilities, and state officials quickly became reliant on *EMResource* as a way to provide essential elements of information with response partners at the local, state, and federal levels. This system continues to provide a framework for situational awareness, incident monitoring, and compliance with federal reporting requirements.

*eICS* was one of the first products to be utilized during the COVID-19 pandemic response and continues to be used by the State of New Hampshire, Granite State Health Care Coalition, public health networks, and hospitals to implement and monitor incident management operations. eICS continues to be a valuable resource for emergency planning, communications, response management, and recovery functions. The plan is to continue to roll this asset out to additional health and public health partners.

**EMSupply**, an inventory management system, quickly became the backbone of medical supply and personal protective equipment (PPE) distribution. This system provided an infrastructure to effectively receive, track, and ship requests for PPE and other materials from the strategic national stockpile and commercial vendors to partners in need.

*EMTrack*, the patient tracking module from Juvare, was uniquely leveraged to assist with mobile testing in response to COVID-19. Initially thought of as a resource for patient tracking in pre-hospital settings or during mass casualty events, the underlying structure of EMTrack has proven essential for mobile COVID-19 testing operations and will continue to evolve to meet the emerging needs of the healthcare and public health landscape.

The COVID-19 pandemic provided the impetus for the widespread adoption and use of these systems to help coordinate multi-dimensional and unprecedented response operations. The State of New Hampshire Department of Health and Human Services supports the Granite State Health Care Coalition in its efforts to continue to offer training to partners in both eICS and EMResource.
