

COVID-19 PCR Testing Options

Most health insurance plans cover testing for COVID-19 without a copay, coinsurance, or deductible. Many locations throughout the state including hospitals, pharmacies, primary care offices, urgent care centers and many other locations offer COVID-19 testing.

Persons who do not have insurance or have a health insurance plan that does not fully cover the cost of testing may have access to cover the costs of testing via a New Hampshire Medicaid Limited COVID-19 Testing Benefit.
